**ORDER:**

Through the reference 1<sup>st</sup> cited, the DWO, WCD & SC Dept., Medchal-Malkajgiri District has requested for allotment of Govt. land for construction of working women Hostels which are as shown below.

Through the reference 3<sup>rd</sup> cited, the Tahsildar, Kapra Mandal has stated that as per the Jawaharnagar Village Bhubharathi records the land in Sy.No. 647 to an extent of Ac.5-00 gts classified as Government land and to an extent of Ac.1-20 gts is vacant under possession of the Government and the same may be allotted in favour of District Welfare Officer, Medchal-Malkajgiri District for construction of Working Women's Hostel.

In this regard, it is to state that the Government vide Memo No.20264/Assn.I (1)/2013, dated 06.11.2013 has accorded permission to the District Collector for advance possession of Govt. land in case of transfer of Govt. land, i.e., one Govt. Department to another Govt. Department (under BSO-23) for establishment of Sub-Station (under BSO-24) subject to furnishing regular alienation/transfer of land proposals in full-shape after following the due procedure as requested in terms of G.O.Ms.No.571 read with G.O.Ms.No.61 to the Land Management Authority.

In view of the above, permission is hereby accorded to the DWO, WCD & SC Dept., Medchal-Malkajgiri District to utilize the Govt. land to an extent of Ac.1-20

gts., in Sy. No.647/P situated at Jawaharnagar Village, Kapra Mandal for construction of building for Working Womens Hostel with the following conditions.

1. To fence the land and to use for the purpose of "Working Womens Hostel" only.
2. The title of the land is vested with the Government.
3. The Government may take over the land as on when the land required for other public purpose.
4. If the land is not utilized, for the above purpose within (3) months the same will be taken back without any notice.

The Tahsildar, Kapra Mandal is hereby directed to handover the advance possession of Govt. land to an extent of Ac.1-20 gts., in Sy. No.647/P situated at Jawaharnagar Village, Kapra Mandal for construction of building for Working Womens Hostel to the DWO, WCD & SC Dept., Medchal-Malkajgiri District duly demarcating the land on ground and clearly showing the boundaries under cover of Panchanama & sketch and to submit regular alienation proposals as per the G.O.Ms.No.571, dt: 14.09.2012 in full shape.

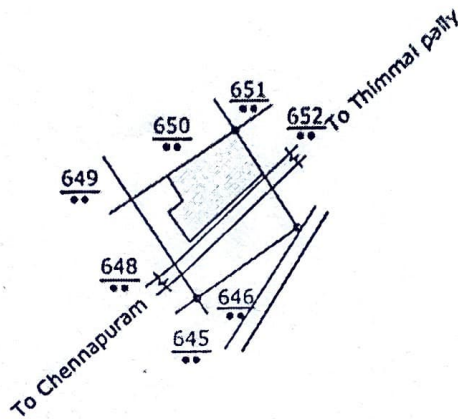

No B/59/2026




